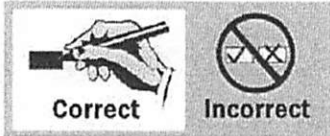

PROPOSITION

Shall Independent School District Number 90 of Osage County, Oklahoma, incur an indebtedness by issuing its bonds in the sum of Three Million Five Hundred Twenty Thousand Dollars (\$3,520,000) to be issued in one or more series to provide funds for the purpose of constructing, equipping, repairing and remodeling school buildings, acquiring school furniture, fixtures and equipment and acquiring and improving school sites, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in such District sufficient to pay the interest on such bonds as it falls due and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to bear interest not to exceed the rate of ten (10%) percentum per annum, payable semi-annually and to become due serially within ten (10) years from their date?

### PROPOSITIONS

#### PROPOSITION

Shall Independent School District Number 6 of Pawnee County, Oklahoma, incur an indebtedness by issuing its bonds in the sum of Nineteen Million Eight Hundred Thirty Thousand Dollars (\$19,830,000) to be issued in one or more series to provide funds for the purpose of constructing, equipping, repairing and remodeling school buildings, acquiring school furniture, fixtures and equipment and acquiring and improving school sites, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in such District sufficient to pay the interest on such bonds as it falls due and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to bear interest not to exceed the rate of ten (10%) percentum per annum, payable semi-annually and to become due serially within ten (10) years from their date?
