There were no Utility Permits.

Kyme Vincent, Nutrition Director approached the Board to provide a presentation on IAAA Grant, Area Agency on Aging Presentation. Vincent stated this will probably be the most important presentation she gives the Board. Vincent stated in the past 30 days, the Elder Nutrition program pulled out of the Fairfax Nutrition site. Vincent stated that the 4-year grant cycle was this past February and that the funding was not good. Elder Nutrition contributed a significant amount to the Nutrition department, and without these funds, there would be a \$60,000 shortfall in the Nutrition budget. A few weeks ago, the Board accepted the grant but Vincent asked the Board not to sign the grant as she believes Osage County is not receiving what they are rightfully entitled. Vincent stated this is a grant that Osage County has received for 34 years. Vincent elaborated that once the contract is signed the County is locked into a 4-year contract with the Area Agency on Aging and in the contract, there is a 40-50% administration fee, making the amounts given to the sites minimal. Vincent stated Osage County has been in contract with Area Agency since 2014. Vincent stated she would like to renegotiate the grant not to include Shidler or Fairfax as the County cannot afford to run 5 sites off the grant. Vincent suggests the grant to only include Hominy, Skiatook and Pawhuska. Vincent elaborated she is not suggesting the Board close sites, but manage the Shidler and Fairfax outside of the grant where the grant could fund Hominy, Skiatook, and Pawhuska. Vincent stated she needs the Board support more than ever to stand up to the Area Agency on Aging. Charlie Cartwright stated his thought would be for the Commissioners to have individual discussions with Kyme Vincent before deciding anything. (#27016)

Cindy Murphy moved to approve and sign the Environmental Quality Review for Capital Fund Work Projects for year 2022-2024 for Osage County Housing Authority. Christi McNeil stated on the Environmental Review most work items are exempt and there are three levels to the review. McNeil stated the review is needed as they start and finish remodels and upgrades included in their 5-year plan. McNeil added there is currently a 40 to 50 person wait list for housing. Anthony Hudson seconded the motion. Hudson-yes; Murphy-yes; Cartwright-yes. Motion carried. (#27017)

Anthony Hudson moved to approve an additional \$250 for cremation for indigent Christopher Eavs to Powell Funeral Home - previously approved September 25, 2023 without a set expenditure amount noted. Charlie Cartwright stated with the amount not stated previously, the funeral home was only paid \$250, but he made an agreement with the Funeral Home to pay them \$500. Gary Upton inquired if Powell Funeral Home has performed services yet and Cartwright stated yes. Cindy Murphy seconded the motion. Hudson-yes; Murphy-yes; Cartwright-yes. Motion carried. (#27018)

Cindy Murphy moved to award Bid #24-15 Generators to Warden LLC for \$28,626 (#26933). Bud Beaston inquired what district the item was for. Robin Slack responded it was for the Rock Creek Fire Department. Anthony Hudson seconded the motion. Hudson-yes; Murphy-yes; Cartwright-yes. Motion carried.

Anthony Hudson moved to approve and sign contract with Comanche County Regional Juvenile Detention Center (CCRJDC) regarding juvenile secure detention service for juvenile offenders for the period July 1, 2024 through June 30, 2025 at a rate of \$40/day. Gary Upton stated this is a standard contract and the standard rate. Cindy Murphy seconded the motion. Hudson-yes; Murphy-yes; Cartwright-yes. Motion carried. (#27019)

JT Darling, INCOG, stated he is here to guide the BOCC through a potential new application for the new grant that is \$600,000 for water and wastewater products. Cindy Murphy moved to open a Public Hearing. Anthony Hudson seconded the motion. Hudson-yes; Murphy-yes; Cartwright-yes. Motion carried. JT Darling inquired if there were any immediate water or wastewater issues in the County would like to discuss. Carol Connor inquired if the RWD would need to be present and Darling responded not necessarily and added he has heard great feedback from RWD #5. Jerry Butterbaugh inquired if this included incorporated towns. Darling responded no. Butterbaugh stated Osage Nation was aware of water needs and inquired if the Osage Nation was involved. Darling stated there is a lot of overlap in the funding with the Osage Nation. Bart Perrier, RWD #5 President, stated they have 40-year-old infrastructure and are in serious need of upgrades to supply lines, tanks, and chlorine systems. Bud Beaston inquired where RWD #5 purchased their water. Perrier responded that it was from Barnsdall City Lake. Beaston asked if water taps were available. Perrier said yes. Anthony Hudson moved to close the Public Hearing. Cindy Murphy seconded the motion. Hudson-yes; Murphy-yes; Cartwright-yes. Motion carried.



Under Citizen's Input, Jerry Butterbaugh inquired for item #9 if there were numbers to support the \$60,000 hole in the budget. Butterbaugh also questioned why Osage Nation withdrew from the program and how much money would be actually put towards Fairfax and Shidler. Charlie Cartwright stated he had the same questions.

Anthony Hudson moved to adjourn. Cindy Murphy seconded the motion. Hudson-yes; Murphy-yes; Cartwright-yes. Motion carried.
