Anthony Hudson moved to approve and sign Collaborative Jail Services Agreement for Sheriff with Family & Childrens Services, Inc. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#27)

Steve Talburt moved to approve and sign Contract for Bid #24-15 Generators for Warden LLC DBA Warten Generators for \$28,626. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#27)

Anthony Hudson moved to approve to pay Dalton Higgins \$3,750 monthly Owners Rep fee for Courthouse Renovation Project from ARPA 1566-1-8020-2005. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to approve District #1 quotes to replace three metal doors from Lucas Metal Works for \$5,049.70 and labor from Blake Cypert for \$3,300 to be paid from Gen Gov Maintenance of Buildings & Structures 0001-1-2000-2050. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#27)

Steve Talburt moved to approve and sign Annual Service Contract for Health Department with Hominy Family Health Center to provide Radiology Services for no more than \$2,500 for July 1, 2024 through June 30, 2025. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#27)

The Board acknowledged letter from Planning & Zoning adding Requisitioning Officer Anthony Hudson and removing Everett Piper from same.

Anthony Hudson moved to approve and sign Cash Fund Estimate of Needs (SAI 308) for Town of Osage for \$1,098.89. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Under Citizen's Input, Kevin Harrison stated this comment has nothing to do with Dalton Higgins personally, but he is concerned the County keeps putting out money for stuff that he feels a County Employee can do, like Tony Reeves. Harrison stated that when you hire a general contractor, they are responsible for taking care of this stuff, and we pay Higgins to oversee a general contractor. Harrison stated he understands that sometimes that's fine, but for the County, we are spending a lot of money that can be better utilized, like improving the Courthouse and inspecting buildings. Harrison stated Tony Reeves is more than capable of inspecting the buildings as he is overmaintenance. He is the one who knows what is going on. Anthony Hudson stated Reeves is not certified to do all of that. Harrison inquired what stops him from being certified to go out and tell the Board what is wrong with a building. Hudson responded, everything; he is not qualified. Harrison inquired what makes Higgins qualified. Hudson stated he took engineers to do it. Harrison asked what Higgins's qualifications were and whether he was an engineer. Hudson stated no, so he took an engineer out there. Harrison stated that makes no sense. Hudson responded individual people know roofing, footage, footings, and everything else. Harrison stated he understands that, but the thing is, the County has someone to take them out there who does not cost any more money. If the Board wants to have something inspected, the Board can call someone out there to have them take a look and ask what the price would be and the companies would give an estimate of the cost of repairs. Harrison stated we do not need to pay someone, which is not an insult to Higgins. This is the fact the County needs to save money and use this money to benefit the County. Harrison went on, Reeves is qualified to take someone out to look at a roof because before, he has had to look at roofs, and he was utilized in the beginning for that and made correct decisions then. Harrison reiterated that it is not against Higgins; it is the County that could be saving money to benefit everyone. Steve Talburt stated they could get into a position where it costs the County more funds because things were not done correctly, and that is why they are trying to safeguard the County by paying Higgins because he is a professional at this. Talburt stated, he does have all his certifications. The Board is safeguarding the County by hiring Higgins to come in and consult on this. I feel like it's better he is ensured and bonded and has a history of taking care of the business that needs taking care of, and the Board is comfortable with that. Harrison inquired if he had certifications. Charlie Cartwright stated he would stop this as it was turning into a debate instead of Citizens' Input, and we're here for a Commissioner's Meeting, not a debate. Harrison thanked Cartwright. Bud Beaston stated in Agenda Item #11 that Dalton Higgins now makes \$3,750 monthly for Courthouse, the March 13th agenda was an inspection of D#3 new shop for \$2,500, the March 4th agenda was \$7,500 of \$42,205 for inspections, and \$11,000 monthly for the Annex for an average amount of \$187,000 paid to Dalton Higgins per year. Beaston inquired where is Robert Smith and the Fairfax Chief, Mike Fisher and Ashley Kane, Everett Piper, Steve Talburt, and Charlie Cartwright, and now Anthony Hudson. Beaston stated Districts 1, 2, and 3 would know about this. He has all the information, and the Board can't stop what is coming. Jerry Butterbaugh said it is an election year, and he is not running for anything. Butterbaugh stated he built over 300 restaurants and 200 convenience stores with Hardys in the 90s. Butterbaugh stated that in today's society, we want qualified people to build things, such as a licensed and bonded architect. If the building were to collapse, it would be on them, and at the same time, there is an assumption that the County's workforce is doing a good job and they are busy. Butterbaugh stated that there was a discussion early on that two previous Commissioners were willing to loan a few employees and equipment to take out the hill where the Annex was being built, and that idea ultimately died



when Piper came into office and locked down the project. The cost has been locked down with contingencies. Butterbaugh stated it has come into the County whether you are talking about Osage Nation or Osage County, we are talking about major projects that have Owner Rep that they don't theoretically have to have if you have an owner who is qualified to do it or if you're a company man with four construction managers. Butterbaugh stated that the attack is now underway and does not serve the long-term benefit. Butterbaugh asked the folks to consider this with reason cause if it does not finish, the County will have a hell of a mess on its hands.

Steve Talburt moved to adjourn. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.
