Anthony Hudson moved to approve Utility Permit #1628 for District #2 submitted by ONE Gas starting at a point in the NE/4 of Section 2, Township 20N, Range 12E crossing N Osage Drive and ending at a point in the SE/4, SE/4 of Section 34, Township 21N, Range 12E and Utility Permit #1629 for District #2 submitted by ONE Gas starting at a point in the SE/4, SW/4 of Section 17, Township 22N, Range 12E crossing at 15518 Colonial Lane and ending at a point in the SE/4, SW/4 of Section 17, Township 22N, Range 12E. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Anthony Hudson moved to open Bid #24-15 Generators. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. The Bids opened were Warden LLC at \$28,626 (#26993), JD'S Electric Inc at \$34,015 (#26994), Generator Supercenter at \$35,280 (#26995), and Bob Dooley Electric at \$39,000 (#26996). Steve Talburt moved to accept all bids for Tabulation. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to table and take under advisement proposal for enhanced road safety and management on Shell Creek Road. Richard Couffer stated there are roughly 500-600 bikes on Shell Creek Road, and local citizens would like a 3-hour restriction from 4:00 PM to 7:00PM Monday through Friday. Rodney Lay stated they had a meeting on March 25 where the Sheriff was present, but District #3 Commissioner Cartwright was not. During the meeting, several issues were discussed, including holding up incoming traffic by riding 3 to 4 cyclist abreast. Additional problem mentioned included cyclists urinating in public on more than one occasion, dogs being maced on private property, cyclist running stop signs and not yielding to the right of way, and even not stopping for school buses unloading and loading endangering lives of children. Lay stated that in the past 20 years, cyclists have not made any effort to reach out to the neighborhood and elaborated they do not want a ban, but a time restriction to allow residents the ability to go home in a timely manner. Chris Carlson stated that the cyclist group has current and past professional racers and that Shell Creek Road is the best place to train. Carlson stated Shell Creek Road is approximately 3 miles and only takes 6-12 minutes for cyclists to travel, and in the last two weeks, the cyclists have not had a single car behind them. Carlson provided the Board documentation that shows the crash maps with zero reports for cyclists in the area. Carlson stated he understands the neighborhood frustration and he has notified the cycling club on multiple pages to ensure they know the issues and how to fix them. Carlson went on to say the cycling group picked up trash a few weeks ago; picking up 145 pounds of trash with only .43 pounds of the waste coming from the cyclists. Carlson apologized to the neighborhood residents and stated the cyclist need to be better and that he was doing what he could to work in this direction. Steve Talburt stated he knows there are good cyclists and those who don't obey the law and understands the citizen's frustration, but the Board needs more information to make a decision. Charlie Cartwright stated he only became aware of this matter on Friday and needed advice from legal on the issue. Jason Waddell stated he is an attorney who has helped shape the laws for cyclists in Oklahoma City and the law in Oklahoma is that there cannot be more than two cyclists abreast when riding, which is for cyclists' safety as cars can try to squeeze by cyclists and hit them. Waddell stated the public does not have the right to unimpeded travel, and if the cyclists' actions are so harmful, local citizens should send out law enforcement. Waddell stated that the Board should not ban a segment of people from a public road as a ban should be the last resort. Lay stated they do not want a ban, just a time restriction. Brian Ingram stated that according to the far-to-right statute, they are failing by being two-abreast and not in a single line. Jerry Butterbaugh stated he used to ride and inquired how someone would be identified if someone were to do an unlawful act. Butterbaugh suggested that the Board or neighborhood enforce restrictions for cyclists to wear club shirts or uniforms so that they can be easily identified if there are law violations. Nathan Krotzer encouraged the Board to pass restrictions because the bikers cause disruptions as the roads in the area are not made for this type of traffic. Cartwright stated he is aware of the issue and will do research and encouraged the neighborhood to contact the Sheriff's Office for more coverage in the area. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#26992)
