Health Department- Updates from Public Information Officer Scott Haywood: We've got some major changes coming up with the Osage County Health Department, as it will kind of affect the way we do business. We are going to be moving to an electronic health record. This is a mandate that came down from the State Legis'lature. We've already rolled out several counties across the state with the electronic health record. It's going great, but it will change the way we do some things. Some of the things that will happen is working on more of an appointment only basis. We will still be able to have some drop-in appointments that you can walk in for. It's going to be a lot like a doctor's office. We are trying to build into the system now. Not a penny will come from Osage County residents, all of it is State funded. March 23rd is when we will start our training and then slowly implement throughout April and May on the electronic health records. It will be better! At some point you will have a patient portal as well.
