There was no citizen input.

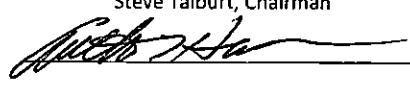

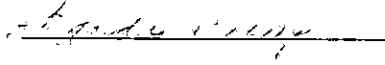

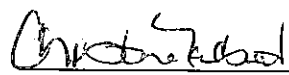
