Talburt stated if we buy a building for \$274,000.00 with the added renovations the total cost would be more. Cartwright stated based on speaking with his constituents they don't want a building. Cartwright also stated we do not need to be looking for property at this point just yet. Steve Talburt moved to deny possible purchasing of a building site in Fairfax for Nutrition. Charlie Cartwright seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Dalton Higgins stated the DA needs 15 points available for data drops at a cost of \$16,049.66. Higgins went on to state an added security station which will be needed will cost \$31,025.00. Along with that, is a cost for labor and administration fees of \$11,653.93. Higgins stated the total for the change orders are \$58,728.59. Higgins stated the changes do not require any more money, there is enough in contingencies money that is already allocated for the Annex Project. Anthony Hudson moved to approve the change order on the Annex Building. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Dalton Higgins, Matt Graves, Brandon Curtis and Jake Kisler gave an update regarding the Courthouse Annex Construction, stating they are on budget and the security system was the main concern while building the Annex. There will be a Security office at the front entrance with bullet proof glass and a metal detector. Everything is on track and Dalton stated the outside of the building will be completed by the end of the month. They are projected to be fully finished by August 12, 2025. There will be one more change order for the mobile shelving for the Assessor's office, but it doesn't need a bid and it is built into the contingency. Matt mentioned that the building is taking shape.
