Anthony Hudson moved to discuss budgets for FY 2025/2026 for the following departments:

- a. Anthony Hudson moved to approve County Clerk budget- Christina Talburt mentioned they can reduce salaries by \$3,000 and M&O by \$25,000. Historically, the Commissioner has approved \$100,000.00 a year for preservation of records, currently doing plat maps. There wasn't requested for the budget last year, so we are a year behind, however this year with reducing by \$25,000 we should be able to pick up and do half of what we would be able to and still make progress. That would be a \$28,000 reduction in the County Clerk's office budget bringing it to \$536,375. There has been no change for General Government or Excise Board. The Commissioners was reduced down to \$2,160 from last year's budget prior to budget submission. On insurance and benefits, Workmans' Comp increased by \$6,197. The Liability and Property went up by \$148,239, an increase of \$73,552 plus an additional assessment fee of \$74,687. The purchasing agent has been vacant for a couple months, so the increase asked for that position can decrease by \$2,000. Data Technology can be decreased by \$25,267. There is no change for Charity. The Highway District for \$75,000 per district was submitted by elected officials and approved prior to budget. The Audit Budget has not changed and is currently at \$66,619.77. We just went through a three-year audit and the Audit budget account is set by the Budget-Maker. We had an increase of \$18,000 due to the expense of a three-year budget. Steve Talburt second the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.
- b. Steve Talburt moved to table Nutrition budget until the invoice issue is resolved with INCOG and the State Jeanie Howerton explained that they're asking for a little more because they need to replace major appliances that are beyond repair. The Health department has been hounding them to get them replaced. In the past the \$80,000 from Gen Gov is what we'd fall back towards at the end of the year. Charlie Cartwright: How's your INCOG funding coming along? Howerton: We've not received a payment from them yet. What I hear from INCOG is the State is trying to redo how I do my invoicing for them. Before I just sent them a list of PO's for them to reimburse me and for what we paid for food at our sites. This year they're just reimbursing us for our meals. Cartwright: What's it going to take to get the invoice problem fixed? Howerton: They haven't paid us for June and I've sent invoices all the way up to August. INCOG is waiting on the State to release the funds. Cartwright: I'd suggest talking to surrounding areas, see who to talk to about straightening up the invoicing problem. Anthony Hudson second the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.
- c. Steve Talburt moved to table Treasurer budget until more information is provided- Bridget West explained that they are only asking for an additional \$15,000 strictly for postage. That's the only change we have. Anthony Hudson second the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.
- d. Anthony Hudson moved to approve Fairgrounds budget- Kelly Pedigo mentioned that they would like an additional \$27,000 from last year because the utilities have gone up. It's on target to exceed last year. They took the part time person off because they get to use the trustees, which has been a big help. Overall, the Fairgrounds reduced their budget by \$27,500. Steve Talburt second the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Under citizens input Jerry Butterbaugh mentioned he has a couple questions. Butterbaugh: On the Foraker Road, is that north or south? Anthony Hudson: North and south. Butterbaugh: Next on item 28, which is about what Mr. Talburt said about the City of Tulsa. Steve Talburt: We had a District #3 property that sat vacant and there was a lot of stuff that needed to be cleaned up. We were never advised that it needed to be cleaned. So, the City of Tulsa sent workers to clean it and charged us back for cleaning it. It was in 2022, so there is nothing we can do about it now. Butterbaugh: Last question is on the Treasurer. When Debbie comes in to auction off properties that did not sell at tax sale. They basically take any number, and any money received I think goes to the County, but I don't know for sure. Usually, she says there's like \$100 to \$150 marketing fee. Someone offered \$100, that might've been a \$3,000 tax bill, we didn't get the tax bill, we got the \$100. The question is could Treasury look at that and when looking at marketing costs, could they factor in some of the department costs? Bridget West: That's what we do, we include those fees on there so the person who's buying is paying for the fees. The County isn't out for those fees. The person paying for it is. Butterbaugh: They're paying for the

marketing and advertising, but you have your operating costs, your salaries. You're not being reimbursed for coming here and for the work that goes into this. It just seems to me it's just too cheap.

Steve Talburt moved to adjourn the meeting. Anthony Hudson second the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.
