Steve Talburt: To continue to work she needs to do something to be done and budgets need to be finished. Anthony Hudson second the motion. Hudson-yes; Talburt-yes; Cartwright-no. Motion Carried.
- b. Treasure Steve Talbut moved to approve the budget for the Treasurer's Office. Bridget West: We are asking for an additional \$10,000 for postage. This is the only change we have. Steve: Could we split the difference and you can still run your department from that. Charlie Cartwright: Can you run your department with what you are currently working with right now. Bridget West: There will be some cuts but we could. Budget will remain the same as last year. Anthony Hudson second the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion Carried.
- c: Sheriff Steve Talburt moved to approve the budget for the Sheriff's office. Bart Perrier: The increased item was budgeted for this year, primarily was for two full time courthouse security deputies and a part timer. With the Annex, we were talking about needing to increase the security. With the courthouse being taken out of commission, I think we can survive without. This is an increase because of a maintenance guy, six vehicles, (which have already been approved). We are moving forward with, the courthouse deputies and dispatcher raises from last year that figure came to \$337,375.00. The proposed budget cuts are two dispatch spots, two courthouse and the part time security increase. The jail maintenance which comes to \$228,200.00. Contracts that are coming in to cover dispatch came to \$226,800.00. So, ultimately, \$228,200 we're looking to cut for this year's budget from the sheriff's office. Steve: I appreciate you working on this and getting it down. Charlie Cartwright: I want to commend you on this, that is a job well done Sheriff. Anthony Hudson second the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion Carried.
