
There were no Utility Permits.

Jerry Roberts announced active Covid-19 cases have increased to 66 cases with the thought of everyone gathering for holidays being the reason for the rise. Scott Haywood stated the big thing right now is the Flu and the Health Department still has Flu vaccinations available as well as take-home Covid tests. No Action.

Randall Jones moved to take No Action regarding the request from Harbor Reserve Residents to move hearing date currently scheduled for December 27, 2022, to a later date in the future to open Section Line per Bonnie Dethrow's request described as Section Line opens at the NE/4 of Section 3, Township 21, Range 11 East and Section 2, Township 21, Range 11 including culverts. Jed Isbell requested the Board to move the hearing date to January as the date is in the middle of the holiday season. Isbell stated a lot of people have a passion for this Section Line and want to be heard. Randall Jones stated there are multiple ways for everyone to be heard including letters to the Board. Steve Talburt stated they are currently in the same place and nothing has changed from the last hearing. Isbell stated they are not in the same place. The HOA is having discussions with the petitioner and trying to move forward. Joe Johnson inquired what the rush is for the opening of the Section Line. Talburt stated it would be best to leave the hearing on the 27th for the two current Commissioners who have been here for the Section Line hearings as they have heard all the information. Darren McKinney seconded the motion. Jones-yes; Talburt-yes; McKinney-yes. Motion carried.

Robin Slack updated the Board on the Courthouse Annex project. Slack started by stating the Board had received an email from Mike Owen, Owner's Representative. Owen's email advised the Board they are nearing a phase where they can start building real budget estimates allowing a clear understanding of the project and funding. Slack stated the email said the BOCC has secured initial funding bond in the amount of \$10,750,000 with payment to the bond to be secured from Use Tax. Slack stated the current projected cost of the budget per Owen's email is \$11,800,000 which is more than what the Bond. Slack stated in the Spring of this year the BOCC Chairman Talburt and herself asked where the additional funds were coming from if the project exceeds bond value. Slack stated it seems now Mike Owen is asking the same question as well. Mike Owen stated he tried to represent the total project cost with the \$11,800,000 and what they currently have is projected budget as they have not identified the scope of work yet. Owen stated the more they move forward with the design; they will be able to include real materials and systems. Owens stated right now this is just a hypothetical number. Slack stated the hypothetical number worries her as she has been inquiring where the additional funding will come from since April. Slack went on to state that her line of questions had drawn unwanted attention from the local paper and has been given a hard time for questioning the financing of the annex project, specifically where funds would come from if more than the bond value. Slack stated she thinks Owens is seeing now what she and Chairman Steve Talburt saw back in April. Slack went on to voice additional concerns regarding the Geotechnical report by Burgess stating she has read the report highlights and has concerns. Slack stated there were to be 5 digs to be done going a depth of 20 feet and not once was the company able to complete planned task. Slack stated she does not think the County should do any dirt work or excavation and that scope of work should go back to the contractors as it was originally planned. Slack went on to state she has no interest in the County taking on that liability after reading the report. Owen stated it is an initial sub surface investigation that will be given to AIP that will then go to AIP structural engineers. Owen expressed when reading that report he sees pleasant conditions as the soil conditions are low PI materials and will not require any crazy foundation designs. Owen went on to state the report states the building will be on a shallow sub surface foundation above the bed rock. Slack stated she is not an engineer, but the report looked concerning to her. She inquired if the County will still be doing the dirt work. Owen stated that is the County decision to make. Steve Talburt inquired to Mike Owen asking so at the end of the day the County will not go over the budgeted amount. Slack stated in the email it was worded for the County to start looking for additional funding. Randall Jones inquired where they were with the design. Owen stated the next milestone is the 35% drawing and the next schematic design meeting is on Thursday with the two new Commissioners invited as well as Judge Stuart Tate. Owen stated the Planning and Zoning Board approved the closure of the road recently and Owen stated he has spoken with City Manager of Pawhuska regarding the road closure. Owen stated the agenda item will be on the next City Council meeting. Owen announced there may not be a need to rent temporary storage units as a possible solution has been considered. Talburt thanked Slack for the update.





Randall Jones moved to approve use of deductible fund in the amount of \$6,275.65 for loss that occurred on 2016 Dodge Ram Vin #1C6RR7XT9GS402479 on November 28, 2022 for Sheriff. Darren McKinney seconded the motion. Jones-yes; Talburt-yes; McKinney-yes. Motion carried. (#25736)

Darren McKinney moved to take No Action on the proposal of First Net Proplus for Sheriff's fleet including vehicle maintenance reminders, collision reconstruction, active tracking, roadside assistance, etc. for a monthly fee of \$19.75/per vehicle. Ronnie Stevens stated this service is provided by AT&T and the Sheriff's Office want to have the service installed on 25 vehicles. Stevens stated there would be a one-time fee of \$6,000 for the hardware and a monthly fee \$19.75 per vehicle. Stevens stated this would help track the deputy speed as well as deputy location. Steve Talburt inquired if they could table the item for a week and get a better set of numbers for the Board. Stevens agreed and stated he would also provide further research on road side assistance program offered with the service. Randall Jones seconded the motion. Jones-yes; Talburt-yes; McKinney-yes. Motion carried.

Darren McKinney moved to table Resolution to pay \$5,851.00 from ARPA Fund (Account 1566-1-8020-2005) for parts, labor, mileage, and replacement of the facility light cells on air purification units with proactive air solutions previously known as Germinator. Randall Jones seconded the motion. Jones-yes; Talburt-yes; McKinney-yes. Motion carried.

Randall Jones moved to approve and sign Lease Purchase Agreement for District #2 with Arvest Equipment Finance for a 2023 Western Star 49X Vin 5KKHBWDV3PPUK7064 with 2022 Godwin 500TLHWL Dump Body Serial #GM77127-B with 2022 Buyers Muni Snowplow Serial #22936 at a unit price of \$197,023.58 payable over a 72-month term. Darren McKinney seconded the motion. Jones-yes; Talburt-yes; McKinney-yes. Motion carried. (#25737)

Darren McKinney moved to approve and sign Fiscal Year 2022 Emergency Management Performance Grant (EMPG) Program including conference and training attendance, reimbursement special projects totalling \$800 for reimbursement. Randall Jones seconded the motion. Jones-yes; Talburt-yes; McKinney-yes; Motion carried. (#25738)

Randall Jones moved to approve to allow the Election Board to use the Fairgrounds from 8AM to 6PM for early absentee voting in 2023 for the dates of January 5-6, February 9-10, March 2-3, March 30-31, May 4-5, June 8-9, July 6-7, August 3-4, September 7-8, October 5-6, and November 9-10. Darren McKinney seconded the motion. Jones-yes; Talburt-yes; McKinney-yes. Motion carried. (#25739)

Darren McKinney moved to approve and the sign the November Reports from County Clerk Reconcilement (#25741), County Clerk Cashbook Summary (#25742), Health Department Reconcilement (#25743), Assessor Reconcilement (#25744), Sheriff's Service Fee Account (#25745), and Sheriff's Jail Account (#25746). Randall Jones seconded the motion. Jones-yes; Talburt-yes; McKinney-yes. Motion carried.
