

December 18, 2023

The Board of County Commissioners of Osage County met at 10:00 A.M., December 18, 2023, in the OSU Extension Building at Osage County Fairgrounds. Members present were Everett Piper, Steve Talburt, and Charlie Cartwright.

Steve Talburt called the meeting to order.

Everett Piper led the prayer.

Steve Talburt led the flag salute.

Under New Business, Sally Hulse stated a tragic accident took the lives of Jennifer Adair's two daughters. Ed Quinton inquired if the County could come together and send flowers from the General Fund. Cartwright inquired if they could legally do that. Hulse stated there is an Officer fund that has roughly \$125 and these funds could be used for this purpose. Hulse stated in the past Elected Officials have contributed \$36/year towards this fund, but because the fund was healthy, Hulse had not requested any funds recently. Robin Slack stated if the elected officials would put in the \$36 it would bump up the amount. Ashley Kane stated she is not sure if the County can use the General Fund and thinks Hulse has the right idea. Steve Talburt stated he is fine with using the Elected Official's Fund. Robin Slack announced the Courthouse will be closed next Monday and Tuesday for Christmas and the last BOCC Meeting of the year will be next Wednesday.

Everett Piper moved to approve and sign minutes for December 11, 2023, with the amendment of "this contract was approved in a previous meeting and Piper, therefore, proceeded per the BOCC directive". Piper stated the Minutes were not inaccurate, but incomplete and would like the amendment to be added. The unamended Minutes of December 11th read "Everett Piper stated that the temp storage space for the Courthouse Annex Project is across the street from the District #1 Shop and owned by Robert Davis. Piper stated they signed the Contract for \$800/month. Robin Slack requested a copy of the contract since it was signed outside of the meeting". Everett Piper moved to approve Utility Permit #1615 for District #3 submitted by One Gas Inc. starting at a point in the SW/4, NE/4 of Section 25, Township 20 North, Range 10 East crossing or parallel to 17594 Shell Creek Road and ending at a point in the SW/4, NE/4 of Section 25, Township 20 North, Range 10 East. Charlie Cartwright seconded the motion. Piper-yes; Talburt-yes; Cartwright-yes. Motion carried.

Christi McNeil presented the Board with the Annual Audit for the Housing Authority of Osage County for the year ending March 31, 2023. McNeil stated the Housing Authority must have an annual audit as the Authority receive more than \$750,000 of federal funds. The audit covers the financial operation as well as a sampling of 20% of tenant files. McNeil stated dwelling rents have increased over the last 2-3 years. McNeil went on to state that the subsidies the Authority receive decrease with the increase in occupancy. Occupancy in the past year is at 95%-97%. McNeil stated there were no findings found in the audit. Sally Hulse inquired what the rent price was based on. McNeil stated housing should not be more than 30% of any tenant's income and a formula is used to calculate the rent based on income and deductions for the tenant. (#26763)

The Board signed an updated 2024 Holiday Schedule. Robin Slack stated the item was approved last week.

Charlie Cartwright moved to approve and sign revised rental agreement for Temporary Storage of Courthouse Annex related files. Everett Piper stated the agreement is for \$800/month for use of ¾ of the building. Piper went on to state the County needs the whole building which will bring the contract to \$1,000/month. Piper suggested the County pay for the next 13 months. Piper stated this will be the first invoice using the new system which starts with the invoice being sent to Mandy Garrison at District #1, Dalton Higgins will review the invoice to ensure work was completed, then viewed by the BOCC and sent to BancFirst to be paid. Everett Piper seconded the motion. Piper-yes; Talburt-yes; Cartwright-yes. Motion carried. (#26763)

Everett Piper moved to approve a \$250,000 payment to Osage County Industrial Trust Authority (OCIA) per Resolution #24657 executed on July 26, 2021. Robin Slack stated that OCIA has completed the audits for the most recent two years and the previous Board has approved upon completion of the audit. Steve Talburt inquired if the money was set aside. Slack responded the money was available for OCIA. Charlie Cartwright seconded the motion. Piper-yes; Talburt-yes; Cartwright-yes. Motion carried. (#26772-#26774)

Everett Piper moved to approve to accept quote from Warner Consulting for \$49,209 for the installation of a new and upgraded sound system for the Women's Building, Ag Building, and Outdoor Arena at the Fairgrounds. Steve Talburt announced two other quotes from York Electronic Systems for \$84,696.33 and Blue Speed AV for \$149,133.31. Charlie Cartwright seconded the motion. Piper-yes; Talburt-yes; Cartwright-yes. Motion carried. (#26775-#26777)

Charlie Cartwright moved to approve and sign an Interlocal Agreement for District #2 with Sperry Public Schools for period ending June 30, 2024. Everett Piper seconded the motion. Piper-yes; Talburt-yes; Cartwright-yes. Motion carried. (#26778)

Everett Piper moved to approve and sign contract for District #3 with Windstream for phone, internet services, and equipment. Charlie Cartwright stated the internet will allow for more workstations and the installation price is cheaper than what is currently utilized. Cartwright stated the one drawback is the District cannot transfer calls to different Districts; however considering the cost savings this is the correct system. Charlie Cartwright seconded the motion. Piper-yes; Talburt-yes; Cartwright-yes. Motion carried. (#26779)

Under Citizen's Input, Jerry Butterbaugh inquired if item #15 would include a speaker and microphone for the Women's Building. Steve Talburt stated they will have handheld microphones. Butterbaugh inquired if copies of the Housing Authority audit are public and if the County is short on housing. Christi McNeil stated there is a nationwide shortage of housing. McNeil stated there is currently 25 to 35 families on a wait list for 2- or 3bedroom homes in Pawhuska. McNeil went on to state that she had been in contract with Stone Ridge Apartments and they have a wait list of 25 to 35 families as well. McNeil stated Butterbaugh could request a copy of the audit from the Authority's office.
