There were no Utility Permits.

Gary Upton inquired about updating the County Emergency Management Plan when emergency situations arise. Upton stated the occurrence of the solar flare last week had him research Osage County's current Emergency Plan. Upton stated the last time the plan was updated was in 2013 and there was no information regarding an EMP attack. Steve Talburt stated he spoke to Jerry Roberts regarding the plan. Jerry Roberts stated the plan is updated every ten years. Roberts elaborated that the plan is in process and currently 36 complete. Everett Piper inquired if they are looking at other County's plans during the update. Roberts stated they look at the State. Piper inquired what the timeframe is for the finished plan and Roberts stated 2-3 weeks.

Everett Piper moved to table Planned Maintenance Agreement for the Sheriff with Clifford Power for \$1,514.00 for all preventative maintenance inspection on a semi-annual basis. Everett Piper inquired if this agreement will overlap with the deferred maintenance plan that the County signed with Higgins. Gary Upton stated he does not have the answer. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.

Everett Piper moved to approve and sign Facilitator Agreement with South 99 Equipment Sales & Marketing LLC for Sheriff whereas the County (seller) will pay facilitator 10% commission rate per piece of property up to \$750.00. Ryan Walker stated this is the same agreement the Board signed in December that will allow them to sell their surplus items in an online auction. Ashley Kane stated it is good to approve. Ted Smith seconded the motion. Piper-yes; Talburt -yes; Smith-yes. Motion carried. (#26895)

Everett Piper moved to table quote with Offender Watch for \$6,500.00 for the annual fee for Sheriff. Gary Upton stated he is working with both legal teams. Ashley Kane stated they still need to discuss liability. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.

Everett Piper moved to approve and sign VOCA Special Conditions for 2023 for the Sheriff. Kevin Young stated this is a grant from the State that will provide for the victim advocate for the Sheriff's Office. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried. (#26896)

Everett Piper moved to approve and sign all services fixed-rate contract renewal between the Department of Corrections, Community Sentencing, and the Osage County Sheriff where renewal is in effect from July 1, 2024, through June 30th, 2025. Steve Talburt stated this is a standard contract. Ted Smith seconded the motion. Piperyes; Talburt-yes; Smith-yes. Motion carried. (#26897)

Everett Piper moved to table use of the County Deductible Fund 2023/2024 for Sheriff loss in the amount of \$4,117.73 that occurred on October 1, 2023 to 2023 Ford Vin #1FM5K8AB7PGA62636. Everett Piper inquired why the Sheriff's Office and Health Department use the deductible fund when both departments have substantial cash reserves. Robin Slack stated that she is not sure about the Health Department; however, the Sheriff's Office cash reserves she thinks per the bond vote may be specifically for the Jail. Steve Talburt stated the cash fund was moved to the Sheriff's Office and Jail. Ashley Kane read the proposition from 2010 stating it is for the Sheriff's Department and Jail. Piper stated he has had constituents inquire why the two departments are not using their respective reserves. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.

Everett Piper moved to table the use of the County Deductible Fund 2023/2024 for total loss to the Sheriff's vehicle in the amount of \$50,090.00 that occurred on January 4, 2024, to 2023 Ford Vin #1FM5K8AB3PG80163. Kevin Young stated the \$50,000 will be paid back from insurance and inquired where it will go. Sally Hulse stated the money would go back to the original account it came from. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.

Everett Piper moved to table the use of County Deductible Fund 2022/2023 for roof replacement for the Health Department where the replacement cost is \$61,914.12 less depreciation is \$22,405.13 and the actual cash value is \$39,508.69. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.

Everett Piper moved to approve and sign Lease Agreement for Health Department with Virginia "Ginni" Young for property located at 5265 W Rogers Blvd, Skiatook OK 74070 where the term of the agreement begins on March 1, 2024, and ends on June 30, 2024, at a rate of \$2,280 (\$570.00/monthly) for four (4) month term. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried. (#26898)

Everett Piper moved to approve and sign ODOT Form 324A for right-of-way services by Pinnacle Consulting Management Group for Parcel 2, 2.1 on J/P 34579 (04) Blackburn Washout for District #3. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried. (#26899)

Everett Piper moved to approve and sign letter of support for application for Bridge Investment Program (BIP) grant funding for the Belford Bridge J/P 25444 which crosses the Arkansas River between Pawnee and Osage County for District #3. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried. (#26900)

Ted Smith moved to table discussion regarding the Building Project Account and balance of District #3 shop allowance. Everett Piper seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.

Everett Piper moved to table contract with Survival Flight EMS for Services for the Town of Fairfax for \$5,500/month. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.

Everett Piper moved to approve payment to Pictometry (Eagleview) in the amount of \$188,845.83. Ed Quinton stated two years ago this contract was originally passed for Pictometry to be paid from the General Fund. Quinton went on to add all offices have access to this program and Osage County has a 10-year contract with Pictometry, the only County in Oklahoma with this extended contract. Quinton stated this will save money for the County for years to come compared to executing a yearly contract. Quinton stated the program allows access to see recent home improvements or new buildings in the entire County every year. This helps to increase the tax roll with the program proving far more benefit and truly paying for itself. Quinton stated that E911 pays \$40,000 from their respective budget, but Quinton does not see the point as the E911 budget comes from the General Fund. Steve Talburt stated he agreed. Kevin Harrison stated he uses Eagleview for insurance and inquired why the price is so high. Quinton stated the County is paying for 1.4 million acres to be assessed. Robin Slack inquired if the approval is for the bill in its entirety of \$188,845.83 or with E911 paying the \$40,000. Talburt stated since E911 has already budgeted for this year expense, E911 should pay their portion of \$40,000 this year, however moving forward it makes more sense for General Fund to pay the bill in its entirety. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried. (#26901)

Everett Piper moved to approve and sign Resolution selecting Kellogg as a consultant engineer for Bridge 86 Bird Creek for District #1 (J/P 36116). Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried. (#26902)

Under Citizen's Input, Bud Beaston inquired about what was wrong with the bridge mentioned in agenda item #24 and who the engineer. Anthony Hudson stated a new bridge is needed. Everett Piper stated they chose the engineer internally after interviewing with each engineering company. Beaston stated Jake Bruno told him the County had an engineer through ACCO for roads and bridges. Talburt stated that is true and Piper stated for every project they interview three companies and select one. Ted Smith stated they follow the CED guidelines to stay compliant. Jerry Butterbaugh inquired if there was an amount for item #14 and Leah Quinton responded there was not a price on the agreement. Kevin Harrison inquired if the County has RCV - Replacement Cost Value or ACV - Actual Cost Value insurance. Harrison went on stating if the County has RCV they should receive two checks, one prior to project and one when documentation is submitted showing the project is complete. Robin Slack stated she remembers seeing an email mentioning two checks one for the work; as well as a second after the work is completed. Slack said she would look further into this matter. Bud Beaston inquired if the Board checks the roofs and Talburt responded no the Board gets estimates on the roof.

Everett Piper moved to adjourn. Ted Smith seconded the motion. Piper-yes; Talburt-yes; Smith-yes. Motion carried.
