

January 8, 2024

The Board of County Commissioners of Osage County met at 10:00 A.M., January 8, 2024, in the OSU Extension Building at Osage County Fairgrounds. Members present were Everett Piper, Loren Vaughan-1st Deputy for Steve Talburt, and Charlie Cartwright.

Charlie Cartwright called the meeting to order.

Everett Piper led the prayer.

Loren Vaughan led the flag salute.

Under New Business, Sally Hulse stated at the end of December the Treasurer's Office collected \$28.8 million, 63% of the total \$43 Million tax collection for the year. With the addition of \$6 million collected so far this year put the County at 75% collected. Hulse stated today the Treasurer's Office will electronically wire the money to the cities and schools. Hulse also announced the Use Tax came in for this month at \$185,000 compared to last month at \$195,000. Everett Piper inquired if the tax roll has gone up compared to last year. Hulse stated compared to last year they are up roughly \$3 million.

Loren Vaughan moved to approve Utility Permit #1616 for District #1 submitted by Capturepoint LLC starting at a point in the NE/4, SE/4 of Section 22, Township 27N, Range 5E crossing or parallel to S Cooper RD and ending at a point in the NW/4, SW/4 of Section 22, Township 27N, Range 5E. Everett Piper seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried.

Matt Clark stated there has been some confusion and complaints from employees regarding employee parking with the start of the construction project. Clark stated this is more of an employee discussion than a Board discussion. Clark went on to state the parking lot is being cut down because of the fencing around the construction site. Clark stated there will no longer be assigned employee parking. Clark went on to say this is not something that the Courthouse Security can monitor. Clark stated there will be parking issues on January 22nd as there is a jury call with 200 letters being sent out as well as Fridays with full dockets in the courts. Everett Piper stated with the construction there will be a few challenges. Piper went on to state the North parking lot that is not fenced off should help for normal days of business. Piper stated he will work on getting additional signage for the public and went on to state Employees will have to walk. Clark stated for jury duty he has spoken to Judge Tate and it will be hectic with cars lining Grandview and Matthews.

Everett Piper moved to approve and sign ODOT Form 324A for District #2 for JP 34578(04) - W 155th PL (Holt Road) embankment repairs for \$4,381.22. Loren Vaughan seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried. (#26801)

Loren Vaughan moved to table to the reappoint of Bruce Gerhold and Leslie Bias for a 6-year term to serve as a member of the Osage County Floodplain Board to expire on December 31, 2029. Jake Bruno stated Gerhold and Bias have been reappointed previously and does not see any issues. Bud Beaston stated he has spoken with Steve Talburt and was under the impression this agenda item would be tabled until Talburt is back as the reappointments are in District #2. Charlie Cartwright inquired if this is a people problem or a process problem. Beaston responded Both and went on to state the two people up for reappointment voted for two items that now flood in District #2. Beaston stated he would like to see someone else on the Board with experience. Loren Vaughan stated he spoke with Talburt and does not mind tabling the item. Everett Piper asked Bruno if there was any action item that will be affected by tabling this item. Bruno stated no there is not and reiterated the Floodplain Board does not see every project only the projects in the special floodplain zone. Everett Piper seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried.

Loren Vaughan moved to approve and sign December 2023 report for the Health Department Reconcilement. Everett Piper seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried. (#26802)

Loren Vaughan moved to approve and sign Cash Fund Estimate of Needs (SAI 308) for December 2023 Receipts. Everett Piper seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried.

Loren Vaughan moved to approve Transfer for Sheriff from Sheriff Service Fee M&O (Account 1226-2-0400-2005) to Salaries (Account 1226-2-0400-1110) for \$50,000. Everett Piper seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried.

Loren Vaughan moved to approve and sign Resolution for Sheriff to Transfer the following to Sheriff's inventory from Courthouse Security Inventory B-218-22.5 Dell OP 7090 cost of \$1,223.45. Everett Piper seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried. (#26803)

Under Citizen's Input, Jerry Butterbaugh inquired about the Floodplain Board being a subgroup of Planning and Zoning Board and questioned how many members overlap. Jake Bruno stated all the members of the Floodplain Board are on the Planning and Zoning Board. Butterbaugh stated if there is discussion on people, he hopes to see the Board go to Executive Session. Butterbaugh encouraged the Board to ask county employees to park elsewhere so the jury selection can park at the Courthouse. Butterbaugh also suggested the Board ask Osage Nation if there is parking available the County could lease or create parking for the time being. Piper stated he will get in contact with someone from Osage Nation regarding parking. Nona Roach inquired about the handicap parking spots. Matt Clark stated they have opened the spots along the concrete wall for the handicap. Bud Beaston asked how the nomination process for the Floodplain Board works as he could not find the process. Charlie Cartwright stated he does not know but Beaston can ask Jake Bruno. Beaston inquired if Bruno will help him. Bruno stated he will to the best of his knowledge.

Loren Vaughan moved to adjourn. Everett Piper seconded the motion. Piper-yes; Vaughan-yes; Cartwright-yes. Motion carried.
