

The Board of County Commissioners of Osage County met at 10:00 A.M., June 3, 2024, in the OSU Extension Building at Osage County Fairgrounds. Members present were Interim Anthony Hudson, Steve Talburt, and Chairman of the Board, Charlie Cartwright.

Charlie Cartwright called the meeting to order.

Charlie Cartwright led the prayer.

Anthony Hudson led the flag salute.

Under new business, Robin Slack stated that the County Clerk office has a young adult from the Osage Nation Youth Employment Training Program working in the office this summer. The Osage Nation wholly pays for the program with no cost to the County. Slack stated there was never a chance the employees would not be paid as payroll had already been run even though the Board had an Emergency Meeting last week. Steve Talburt asked why it was not on the agenda as it typically is. Slack stated she usually included the words payroll, but she has spoken to the auditors, and it does not have to include this wording for payment and the reason she had include was more for notification purposes. Slack said the payroll had already been run, so it was never an emergency.

Anthony Hudson moved to approve and sign minutes for Regular and Emergency Meeting of May 28, 2024. Steve Talburt stated that one thing he saw on the Emergency Minutes in the comments was that some sentences were incomplete. Robin Slack stated she interrupted Cartwright. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to approve Utility Permit #1632 submitted by ONE Gas Inc. starting at a point in the NE/4, SE/4 of Section 30, Township 20N, Range 11E crossing at 16743 E Shell Creek Rd and ending at a point in the SE/4, NE/4 f Section 30, Township 20N, Range 11E. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.



Anthony Hudson moved to table update on the Courthouse Annex Project from Dalton Higgins. Anthony Hudson stated Higgins would not be able to attend this meeting. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to table how to account for time away from work for the employees impacted by the Barnsdall tornado on May 6, 2024. Robin Slack stated Tony Reeves inquired about how to handle timesheet because he and another employee in his department were both impacted by this emergency. Slack stated she believe other District #1 employees were also impacted. Anthony Hudson said he had three employees who were affected, but they had enough vacation time. Ashley Kane stated she thinks leave with pay would be fine since the County was in an emergency, but suggested the Board check with SAI. Slack said she would be happy to reach out to SAI for clarification on the matter. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to award all low bids based on project location and transportation cost; waste fees to be based on Oklahoma Statutes for Bid #24-21 Road and Bridge, Bid #24-22 Grader Blades, and Bid #24-23 Tires. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to open Bid #24-24 Election Ballots and Bid #24-25 Road Sign Blanks. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. Charlie Cartwright announced two bids for Election Ballots from Royal Printing Company and Mid-West Printing Comp. Cartwright announced one bid for Road Sign Blanks from Vulcan Inc. Steve Talburt moved to accept all bids for Tabulation. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

The Board acknowledged letter from the County Clerk stating Rebekah Reeves as 1st Deputy.

Anthony Hudson moved to approve and sign State Fiscal Year 2025 with the Oklahoma Department of Mental Health and Substance Abuse Services for period July 1, 2024, through June 30, 2025, including Criminal Justice - Drug Court Administration for \$30,000, Criminal Justice - Early Diversion Adult State for \$21,250 and Criminal Justice - Mental Health Court Administration for \$60,000 Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Anthony Hudson moved to approve quote from Metro Carpet & Tile for \$19,157.18 for Flooring in the Sheriff's business offices and common area. Additional quotes obtained were from Anderson Flooring for \$24,900 and JERRICO Tile & Carpet, Inc for \$21,963.42. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to approve quotes from Merrifield Office Supply for \$6,239 for miscellaneous office supplies for Rock Fire Department REAP #240138. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to table two payments of \$62,166.17 (totaling \$124,332.34) from Bond Reserve (Account 1301-1-2000-5210). Sally Hulse stated OCIA has requested a double payment be made, but it will affect what is given to the Fairgrounds and General Fund. Hulse noted that the County initially gave OCIA \$800,000. Nona Roach stated OCIA no longer have the \$800,000 and went on to state OCIA paid roughly \$180,000 on taxes. Charlie Cartwright stated he would like to table this for one week. Jerry Butterbaugh stated he understands tabling the matter, but every payment has been late in the past nine months. Cartwright stated he is uncomfortable with making a decision today as he has been unable to speak to anyone regarding the matter. Hulse stated the payment should always have been on time. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to approve payment to Osage County RWD#20 for Engineering services for \$1,850 to be paid for with 18622 CDBG 22 and 18623 CDBG 21 Grant Funds (Account 1400-1-1000-2005). Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to approve to correct Misc #26902. Anthony Hudson stated back in February they approved Kellog Engineering for a project, but Guy Engineering was erroneously input. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Anthony Hudson moved to table application for Older Americans Grant for Nutrition for Title III for \$550,786; Local Donations for \$30,000; Grantee Cash for \$80,000; and NSIP for \$29,113 totaling \$689,899 for 34 years of delivered meals. Charlie Cartwright asked Ashley if they could still move forward as this is a 4-year contract, and the Agenda



has a typo of 34 years. Robin Slack stated that Nutrition has been doing this project for 34 years and there is not a typo. Cindy Murphy inquired if this is the same contract with the missing \$80,000 on the cover page. Cartwright stated yes. Cartwright asked Kane if she was good with the contract. Kyme Vincent, Nutrition Director, stated there is a problem. This paperwork did not come out of her office and she had no idea who generated the paperwork. Vincent stated there is a federal grant process that has to be followed and she doesn't know how this happened. Cartwright stated it happened directly with advice from INCOG on handling this, which is why you have the \$80,000 in this location. Vincent stated the problem is INCOG cannot change the application during the grant process, and at this moment in time, you need to file an addendum, which she asked for a few weeks from the Board, so they can discuss rewriting the grant and resubmitting. Vincent stated she has already talked to other people, and there is potential that this entire grant will be thrown out because there was a violation. Vincent stated a grant cannot be altered once submitted, and it is not up to her if this grant process has been violated. It is up to the State. Vincent suggested that the Board table the item because someone needs to talk to the State and the ACL at the federal level to see if the grant process has been violated. Cartwright stated that his understanding Regan McManus spoke with the State, and this is how they told the County to proceed. Vincent stated that many people can say many things, and this federal grant is thousands of pages with each person in the network having responsibilities. Vincent stated she did not write this grant, and this is not a budget that has been submitted, and she does not know why they gave Cartwright that information. Vincent stated there are too many issues with this Agenda item to cover. Cartwright stated there has been one thing changed on the application: the amount the grantee supplies. Vincent stated there was a conversation in 2012 about why we do this. Cartwright stated Ashley Kane now has the floor. Ashley Kane stated she had seen the contract from Kyme about a month ago, but she has not seen this contract. Cartwright inquired if Kane had seen the change in the cover page. Kane stated she had not seen any of the documents involving INCOG. Vincent stated the question comes to who changed the cover page. Cartwright stated he had changed it on INCOG's advice. Vincent stated exactly, that is a violation of the federal bid process and I take no joy in telling the Board this information. Cartwright stated that is her determination. Vincent stated no, it is the State and Federal government's determination. Cartwright stated that is her determination. Vincent stated she really suggests the Board tables the item. Cartwright stated to table one week for Kane to review the change on the cover page and proceed without a doubt. Vincent stated she would let the State and Federal levels know what happened and it's probably not the end of the world, but what would happen would be up to the Area Agency on Aging. Cartwright said thank you. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to approve Transfer for \$12,000 from D#2 Retirement (Account 1102-6-4200-1221) and \$5,000.00 from D#2 Insurance (Account 1102-6-4200-1222) to D#2 Property Insurance (Account 1102-6-4200-2065). Steve Talburt stated property tax is going up so District #2 is transferring the money to put cushion in the account. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

The Board acknowledged receipt of \$21,722.76 from Opioid Abatement Settlement.

The Board acknowledged receipt of \$42,035.90 from Opioid Abatement Settlement.

The Board acknowledged payment of \$6,006.24 from ACCO for loss to 2023 Ford Police Interceptor Utility Vehicle (VIN# 1FM5K8AB5PGA62537) for Sheriff.

The Board acknowledged payment of \$8,386.87 from ACCO for loss to 2021 Chevy Silverado 1500 Crew Cab (VIN# 3GCUYAEF8MG242503) for Sheriff.

Under Citizen's Input, Jerry Butterbaugh inquired if items #25-29 happened at one time or if May was a bad month. Charlie Cartwright stated he is not sure, but he knows there were a few vehicles that were in Ada for training that experienced hail damage. Bud Beaston inquired about an explanation on item #22 and Cartwright stated they are adjusting available funds. Kevin Harrison asked why the County is paying a RWD and Cartwright stated they are a go-between for the REAP grants and sponsors the RWD, so they are funneling the money through.

Anthony Hudson moved to enter Executive Session as per 25 O.S. Section 307 B. 4. to discuss an Amicus Brief or contact for the drafting of an Amicus Brief in United States V. Osage Wind LLC, Case No. 14-CV-704-JFK-JFJ. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Steve Talburt moved to exit the Executive Session. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.



Charlie Cartwright stated that the Board had decided to take no action on the Amicus Brief.

Anthony Hudson moved to adjourn. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.
