

Under Citizen's Input, Jerry Roberts stated that FEMA was on the ground in Barnsdall in three days, unlike in most cases, which were 6-8 weeks. Roberts noted that the Governor and Legislature helped get FEMA here quickly and they are thankful. Roberts announced there are approximately 800 volunteers per day in Barnsdall that are being tracked with color-coded bracelets that change daily. Roberts stated seven counties have sent their Emergency Management Director or team to Osage County. The State Emergency Management is preparing a plan for the giant piles of debris that must go to a DEQ dumpsite. Steve Talburt stated the Grant prepared by Cindy Murphy and signed today would give \$5,000 to each District to help pay for roll-off dumpsters and such. Roberts stated the debris would all be picked up by FEMA. Terry Sherve stated Barnsdall is devastated, but he could not be more proud the Commissioners and Jerry Roberts.

Steve Talburt moved to adjourn. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.
