Dalton Higgins updated the Board on the Annex Project. Higgins stated the overall schedule is good, and we are also good budget-wise. Higgins said they are adding a fire hydrant as the original hydrant is not tied to the water. Higgins introduced Brandon Curtis with KSB. Brandon Curtis stated the roofing is complete, and they are almost done with the interior framing. All trades are doing rough-ins, and all the exterior stone has arrived. Curtis stated we are slowly cutting time on the schedule, and it is possible to be done before early summer.

Steve Talburt moved to approve opening Bid #25-01 Food and Bid #25-02 Oil, Lube & Antifreeze. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. Charlie Cartwright announced one Bid received for Bid #25-01 Food from Ben E. Keith (#27459). Steve Talburt moved to approve the Bid for Tabulation. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. Charlie Cartwright announced two Bids received for Bid #25-02 Oil, Lube & Antifreeze from Safety-Kleen Systems Inc (#27460) and RelaDyne West LLC (#27461). Steve Talburt moved to approve the bids for Tabulation. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

The Board acknowledged payment from Bond Proceeds to Higgins Construction for \$11,000. (#27462)

Anthony Hudson moved to approve and sign Oklahoma Emergency Management Performance Grant Agreement and Application Packet. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#27463)

Anthony Hudson moved to approve a Planned Service Agreement for Sheriff with Johnson Controls Fire Protection for a total of \$3,517.16. Steve Talburt seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#27464)

Steve Talburt moved to approve and sign Court Clerk Records Management and Preservation Report for October 2024. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried. (#27465)

Steve Talburt moved to approve and sign Transfer for Nutrition for \$46,900 from 1242-3-5200-2005 (M&O) to 1242-3-5200-1110 (Salaries) \$33,000, 1242-3-5200-1210 (FICA) \$3,200, 1242-3-5200-1221 (Retirement) \$4,700, and 1242-3-5200-1222 (Insurance) \$6,000. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

The Board acknowledged receipt of ACCO Performance Incentive Refund Check in the amount of \$32,248 for the 2021/2022 ACCO-SIF Policy term for Favorable Workman's Compensation Group Loss History. (#27466)

Steve Talburt moved to approve taking additional signage for Blackburn Washout JP34579(04) out of the 1103-6-6000-2075 Commissioner Project Account. Kandy Jump stated there was another accident on the road, and the cost would be around \$3,000. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-yes. Motion carried.

Under Citizen's Input, Bud Beaston showed the Board pictures of the Foundation with a level and stated it is off a quarter at the corner due to sinkage making it 1½ inches at 12 feet. Beaston stated they are not using the footers the taxpayers paid for, and this is all on Dalton Higgins's watch. Beaston quoted Talburt from the April 22, 2024, Minutes stating, "They could get into a position where it costs the County more funds because things were not done correctly, and that is why they are trying to safeguard the County by paying Higgins because he is a professional at this. Talburt stated, he does have all his certifications. The Board is safeguarding the County by hiring Higgins to come in and consult on this. I feel like it's better he is ensured and bonded and has a history of taking care of the business that needs taking care of, and the Board is comfortable with that." Beaston quoted himself from April 22, 2024, Minutes stating, "the Board can't stop what is coming." Beaston went on to quote Jerry Butterbaugh stating "he built over 300 restaurants and 200 convenience stores with Hardys in the 90s. Butterbaugh stated that in today's society, we want qualified people to build things, such as a licensed and bonded architect. If the building were to collapse, it would be on them, and at the same time". Beaston stated the building



is sinking in the Southeast corner and he has the records of that. Beaston quoted Nona Roach stating, "The very next meeting they have requested in Citizens Input all the credentials on the Owners Rep, his credentials are substantial, but if you want answers from the BOCC, you get on the Agenda... vote for Steve Talburt". Beaston stated see where this is leading. Charlie Cartwright told Beaston to send the photos and an explanation to his office and that he would review them. Robert Stits stated he would like to yield his time to Beaston. Cartwright stated that the Agenda states per citizen and does not know anything that allows them to yield minutes. Cartwright stated he had not heard of that before, and this is their meeting. Cartwright stated he does not see the need to yield to the same thing because, apparently, they will keep yielding. Cartwright asked Ashley Kane for guidance. Talburt stated time being yielded has not happened in their meeting before. Talburt stated he is handed a paper with Commissioner scandal on top, and in his opinion, he is not convinced based on what he has heard. Beaston stated the photo doesn't lie. Robert Stits stated he would like his time yielded to Beaston. Cartwright stated he would like to table until they have a legal opinion on time yielding. Bill Park stated that if the foundation sank, whether it was a cold pour or hot pour, there was a problem. Park asked the Board what they would do and if they would get an outdoor engineer to look at it. Talburt stated he did not know where or when the photos were taken. Dalton Higgins stated that, like any large project, they followed the architect and engineer's plans, and yes, there were cold pours approved by the engineer. Higgins stated they have had a 3rd party agency come in for inspections, and if they need to, they can get the engineer out to test. Jerry Butterbaugh stated that the construction site is being filmed and that it feels unsafe as we do not know if someone is touching or moving items. Butterbaugh strongly encouraged the Board to arrest anyone for trespassing if they were on the site. Butterbaugh inquired if the Excise and Tourism Board should send a notice for the meetings or post their meeting on the website for everyone to see, as he would like to be notified. Talburt stated I would, too. Nona Roach stated that OCIA has been investing the bond money in Tbills with the help of Higgins, and they have now been able to reduce the monthly payment by \$800. Roach stated she did write what Beaston quoted, and if he wants to discuss this to be put on the Agenda, Higgins is wonderful to work with. Dick Clark stated most of the room can not hear the BOCC during the meetings, and they need to fix that. Clark stated he thinks the BOCC will find that time can be yielded in a meeting. Talburt stated he does not disagree, but time would be yielded to go around in a circle, and they are here to do business. Talburt stated they can speak to their Commissioner, and if it is worthy, it can be placed on the Agenda. Clark stated he would like to ask the Board to make the Agenda more precise. Talburt stated they do not personally write the Agendas. Clark stated that as citizens, we should be able to read the Agenda and understand what is happening. On #10, food is a broad term, and no one knows what food pertains to. Anthony Hudson inquired if they would like all the food items listed. Clark stated that they would like to know what the food would be used for. Talburt stated he could raise his hand on Agenda items that need clarification. Clark stated that a few weeks ago, he was warned to only speak in Citizens Input and not before.

Steve Talburt moved to adjourn. Anthony Hudson seconded the motion. Hudson-yes; Talburt-yes; Cartwright-No. Motion carried.
